PRINCIPAL DESIGNER ADVISER



In this instance, PBS would not be appointed to the role of Principal Designer, but using our skills, knowledge and experience in the industry, will assist the appointed Principal Designer in managing the Pre-Construction Phase and oversee the H&S file compilation. Whilst the role of the Principal Designer Adviser is not outlined in Construction (Design and Management) Regulations, it is a service we offer to aid in managing design risks and in applying the general principles of prevention, as well as ensuring the Principal Designer fulfills all of their CDM responsibilities.



- ✓ Cooperating with any other person working on or in relation to a project at the same, or on an adjoining, construction site
- ✓ Compiling the Pre-Construction information document using information available, or reasonably attainable, to identify potential risks associated with the site and proposed works
- ✓ Ensuring all designers comply with their duties
- ✓ Ensuring all persons working in relation to the Pre-Construction Phase are cooperating with the Client, the Principal Designer and each other
- ✓ Sharing with the Principal Contractor information relevant to the planning, management and monitoring during the Construction Phase
- ✓ During the Pre-Construction Phase preparing a Health and Safety file
- ✓ Ensuring the Health and Safety file is appropriately reviewed, updated and revised
