## FIRE RISK **ASSESSMENTS**



To take the stress and responsibility away from you, we offer a full range of fire safety services. Fire Risk Assessments are carried out by one of our experienced and qualified Assessors. The assessments are documented in a comprehensive, written report with recommendations in the form of "Significant Findings" and an "Action Plan".



Fire Risk Assessments are a legal requirement for all UK businesses and organisations. If you employ five or more people it must be documented and available for inspection.

Under the Fire Safety Order, the aim of a fire risk assessment is to identify the fire hazards; to reduce the risk of those hazards causing harm to as low as reasonably practicable, and to decide what physical fire precautions and management arrangements are necessary to ensure the safety of people in the premises, if a fire does start.

A key pillar of the order is that the responsible person should not only take the appropriate steps to reduce the fire risk, but also be able to demonstrate that they have complied with their duties under the Order.

Before taking any action, the responsible person must make a proper assessment of the risks to which the relevant people are exposed, to identify which measures they must take to comply with the Order. Assessments will depend on the type and function of the property, the users, and the risks associated with that use.

Responsible persons should review regularly their risk assessments to keep them updated and to ensure they reflect any necessary changes.


